COMPLAINT AND MOTION  
FOR TEMPORARY AND  
PERMANENT INJUNCTION  
AND MANDAMUS

**NATURE OF THE CASE**

1. Ohio election codes and procedures currently leave Ohio election officials dependent upon accurate and truthful representations from political parties regarding the qualifications of candidates to hold office. Since the Ohio Secretary of State is required, by oath, to uphold the U. S. Constitution and Ohio Constitution and is required to place on the ballot any filing he receives, as long as he has reason to believe the document is not materially false or fraudulent, he depends upon truthful representations by the Democratic or Republican Party of Ohio that the individual selected by the Party as its candidate for the office of President of the United States has been properly vetted. When

the Ohio Secretary of State receives a document from the Democratic or Republican Party identifying the Party's candidate for President, the Secretary of State is required, unless the candidate's eligibility is challenged, to place the candidate's name on all ballots in all Ohio counties under Ohio Revised Code (ORC) 3501.39. (See attached highlighted Exhibit 1). Section (A)(3) requires the Secretary of State to accept declarations of candidates' filings, unless they violate "other requirements established by law."

2. The function of the Secretary of State in this capacity, as it currently stands, is ministerial, which means that the Secretary of State has no authority to scrutinize the candidates' qualifications to hold office. This procedure leaves the Secretary of State, any opposing candidates, and all the citizens of Ohio completely dependent upon a truthful and accurate representation from a political party that their candidate is qualified to hold the office of President of the United States. ORC 3501.01(H) states:

"Candidate" means any **qualified person** [Emphasis added] certified in accordance with the provisions of the Revised Code for placement on the official ballot of a primary, general, or special election to be held in this state, or any qualified person who claims to be a write-in candidate, or who knowingly assents to being represented as a write-in candidate by another at either a primary, general, or special election to be held in this state."

3. Defendant Husted is the Ohio Secretary of State. A letter from the Ohio Secretary of State Jon Husted dated April 18, 2012 says, in part: "...I do not have the authority to review either the political party's selection process or the qualifications of the joint candidates. [Emphasis added.]" (See attached highlighted Exhibit 2.)

4. Ohio Revised Code (ORC) 111.24:

Refusal of documents for filing or recording.

(A) Notwithstanding any other provision of the Revised Code, if a person presents a document to the secretary of state for filing or recording, the secretary of state may refuse to accept the document for filing or recording if the document is not required or authorized to be filed or recorded with the secretary of state or the secretary of state has reasonable cause to believe the document is materially false or fraudulent. This division does not create a duty upon the secretary of state to inspect, evaluate, or investigate a document that is presented for filing or recording. [Emphasis added.] (See attached Exhibit 3.)

5. This section of the ORC111.24 and the letter from Defendant Husted are in opposition to the sworn oath that Defendant Husted took, prior to assuming the office as Ohio Secretary of State. In his letter Defendant Husted said he does not have the authority to review information by a political party. ORC 111.24 is consistent with that statement of fact there is no duty to evaluate documents provided to him unless the documents presented are fraudulent. There would be no reason to anticipate a political party proffering a document containing fraudulent information to the Secretary of State. However, that is what has occurred. To become the Democratic candidate, Barack Obama engaged in fraud. He has been using a fraudulent social security number since the mid-80s.

6. Before a person is allowed to assume the position of the Ohio Secretary of State he or she is required to pledge to uphold the U.S. and Ohio Constitution. Defendant Husted, took an oath on January 9, 2011, in which he stated: "I, Jon Husted, do solemnly swear that I will support the Constitution of the United States and the Constitution of Ohio, and will faithfully and impartially discharge and perform all of the duties incumbent upon me as the Secretary of State of Ohio according to the best of my ability, and my understanding. And this do as I shall answer unto God."

7. But because the Secretary of State does not “inspect, evaluate or investigate a document,” there is opportunity for an ineligible candidate to appear on the ballot.
8. This Complaint does not request or require this Court to find that President Obama is not qualified or ineligible to hold the office of President of the United States. Instead, this Complaint alleges that sufficient evidence exists to make any reasonable person believe, in light of attached exhibits and the evidence to be adduced at trial, that Barack Obama has repeatedly, consistently, and with intent misrepresented himself by using a fraudulently obtained social security number. Attached as exhibits are supporting documents which evidence the accuracy of that allegation.
9. Defendant Husted has a duty to inspect these supporting documents, since they establish that Barack Obama is not properly eligible to be the Democratic nominee for president in the November 2012 general election and to determine whether his name should be entered as a candidate.
10. This Complaint asserts that the Ohio Secretary of State, Defendant Husted, has the power to set into motion, by allowing Barack Obama’s name to appear on the ballot for the general election in November, 2012, a process that will cause irreparable harm to the Plaintiff, to the State of Ohio, and to the citizens of Ohio. Defendant Husted also has the power and is obligated to prevent this irreparable harm.
11. Plaintiff, through the course of an investigation she has been conducting since 2009, has discovered evidence that Barack Obama has and continues, with intent, to use a social security number not properly assigned to him and that, based on information and belief,

Barack Obama has arrogated a social security number that was previously assigned to another and different person living in the State of Connecticut at the time it was issued. Allegations, supported by attached exhibits, are set forth below. Plaintiff alleges that the proffered documentation is sufficiently compelling as to require the conclusion that any representation by the Democratic Party to any Ohio official which asserts, implies, or states Barack Obama is qualified to hold the office of President, constitutes gross negligence or intentional misrepresentation.

### **PARTIES**

12. Plaintiff is a citizen of the United States and has been a resident of the State of Ohio since 1941. The information contained in the Complaint is based upon her own personal knowledge and investigative work.
13. Plaintiff is currently a registered voter in Geauga County, OH, and has voted in numerous elections for more than forty years, and is free from any mental disease or psychological impairment.
14. Plaintiff has been a State of Ohio licensed private investigator since March 1995 and is in Good Standing as a licensed private investigator with the Ohio Department of Public Safety.
15. Plaintiff holds a B.A. (1978) and an M.A. (1985) from Cleveland State University, was certified (1977) as a paralegal from the Ohio Paralegal Institute, and has been a Notary Public for more than thirty years.

16. Plaintiff, in pursuance of her occupation, is able to access proprietary databases and acquire information from additional sources, including licensed investigation companies across the country.
17. Plaintiff is a valid write-in candidate in Ohio for President of the United States for the November, 2012, election. (See attached Exhibit 4.)
18. Defendant Husted, in the normal course of his duties as the elected Ohio Secretary of State, oversees the elections process and enforces the election laws, which include ORC 3501.06: “There shall be in each county of the state a board of elections...who shall be appointed by the secretary of state, as the secretary’s representatives.... [Emphasis added.]” ORC 3501.13(B) states that “...the director [of the election board)] shall subscribe to an oath that the director will support the Constitution of the United States and the Ohio Constitution”... and...”enforce the election laws....”
19. Under ORC 3501.06 and ORC 3501.13(B), Defendant Husted, through his appointed representative, oversees the election in every Ohio county. (See attached Exhibits 5a and 5b.)

### **JURISDICTION AND VENUE**

20. Plaintiff has been a property owner in Geauga County since May 1998, and lives within the jurisdiction of the Geauga County Court of Common Pleas, and in a voting district included within the jurisdiction of the defendant, as determined by OCR 3501.04 and 3501.18(A). (See attached Exhibits 6a and 6b.) Defendant Husted, avers through his website: “As the chief elections officer, the Secretary of State oversees the

elections process...in each of Ohio's 88 counties." Geauga County is one of the eighty-eight counties.

21. Plaintiff, as a resident of Geauga County, is in the proper venue as defined in the Ohio Rules of Civil Procedure: Rule 3 (B):

"Venue: where proper. Any action may be venued, commenced and decided in any court in any county. When applied to county and municipal courts, 'county' as used in this rule shall be construed, where appropriate, as the territorial limits of those courts. Proper venue lies in any one or more of the following counties: ...

(3) A county in which the defendant conducted activity that gave rise to the claim for relief [Emphasis added]." (See attached Exhibit 7.)

### **FACTS SUPPORTING MISREPRESENTATION**

22. In August, 2009, Plaintiff, in the course of her private investigation practice, was engaged to begin an investigation into the background of Barack Obama.
23. In the initial stage of the investigation, Plaintiff searched for a social security number for Barack Obama. Plaintiff entered the name Barack Obama, IL, into one of the databases to which she has access. The social security number 042-68-4425 appeared with the name Barack Obama and multiple addresses in Chicago and Massachusetts, along with the information that the social security number had been issued in Connecticut between 1977-1979. The year 1890 appears as Barack Obama's date of birth, along with August 4, 1961. Only one page of addresses has been included to avoid unnecessary duplicating. (See attached highlighted Exhibit 8.)
24. Plaintiff, who has verified thousands of social security numbers as a private investigator, understood, on information and belief, that Barack Obama was born in

1961. Plaintiff knew, based on then existing social security protocol, that during 1977-1979, a social security number was assigned by the Social Security Administration on the basis of the state where the person lived when he/she applied.
25. Numbers beginning with “042” were reserved for the exclusive use of Connecticut residents. (See attached highlighted Exhibit 9.)
  26. Further, to support the contention “042” was assigned only to residents of Connecticut, Plaintiff ran the social security numbers of 042-68-4415 thru 042-68-4435. Barack Obama’s number is in the middle of them: 042-68-4425. All of those numbers returned: “Issued 1977-1979 in CT.” (See Exhibit 10.)
  27. Based on information and belief, Plaintiff asserts Barack Obama was never in the State of Connecticut in 1977.
  28. Based on his autobiography, Dreams from My Father, Barack Obama was living in Hawaii from 1971 to 1979.
  29. Plaintiff next entered only the social security number, 042-68-4425. The information provided by the database indicated that 042-68-4425 belonged to Barack Hussein Obama and the dates **1890** (Emphasis added), 08/04/1961 and 04/08/1961. (See attached Exhibit 11.)
  31. The appearance of the year 1890 was a marked anomaly.
  32. Plaintiff has never encountered, during thousands of previous investigations, such an anomaly: a social security number linked to such an erroneous birth year.
  33. When Plaintiff accessed other databases, entering the social security number, 042-68-4425, approximately eight pages of addresses appeared for Barack Obama, one of



which is included as an attachment. The addresses were in Illinois, Massachusetts and in Washington, D.C. (See Exhibit 12.) None referenced the State of Connecticut.

34. The addresses also included Barack Obama's alleged date of birth, August 4, 1961, and a telephone number, 773-684-4809. Randomly, however, the telephone report for Barack and Michelle Obama would again show the year of Barack Obama's birth as 1890. (See attached highlighted Exhibit 13.)

### **THE MISREPRESENTATIONS**

35. Based on information and belief, Plaintiff asserts that Barack Obama began using the Connecticut social security number as his own in the mid-'80s. That number had previously been issued to another person, herein referred to as Mr./Ms./Mrs. X, in March 1977, who lived in Connecticut at the time of application for a social security number, and who had been born in the year 1890.
36. It is possible to determine when a social security number was issued through the examination of the records of Social Security Administration regarding Form SS-5 and the subsequent Numident -- the term is that of the Social Security Administration. It means computer printout. The Form SS-5 was and remains the official application form for a social security number issued in 1977. It is still in use today. The current Social Security Administration website reads, in material part:

Applying for an SSN Today:

“Just as it was in 1936, today a person must complete an application to obtain an original or replacement SSN or to change the information in SSA's Numident records. There are a number of ways to initiate the application process.

“The paper form a person completes to apply for an original SSN or a replacement card or to make changes to SSA's Numident record is still the SS-5. The SS-5 application is available online or in any SSA field office. The application and required evidence can be taken or mailed to any Social Security office for processing. **An in-person interview is required if the applicant is age 12 or older and is applying for an original SSN.** [Emphasis added.] ...The signed SS-5 application is retained for a short period in the field office, and then is sent to a records center in Pennsylvania for microfilming. Once microfilmed, the original SS-5 is destroyed.”

Therefore, though unobtainable to the Plaintiff, a copy of the original SS-5 for social security number 042-68-4425 still exists.

37. Plaintiff alleges that March 1977 was the exact month of issuance for 042-68-4425. That information was derived from the identification of records of other persons with numbers which bracket that of Barack Obama. Plaintiff has attached three affidavits from Paula Hoehn, (see attached Exhibits 14a, 14b, and 14c), who filed FOIA requests with the Social Security Administration. Included are copies of records for social security number 042-68-4424, which belonged to Thomas Louis Wood, born July 15, 1962; 042-68-4429, which belonged to Paul Michael Graziano (originally misidentified by Ms. Hoehn as Paul Grazia) and born September 25, 1967; and for 042-68-4437, which belonged to Margaret Bossing, who was born **January 7 1896**. (Emphasis added.)
38. Thomas Wood, Paul Graziano, and Margaret Bossing are deceased. Hence their records are available.
39. All three persons were issued their social security numbers in Connecticut, where they lived when they applied for them, and all were assigned numbers on March 28, 1977.

Since Barack Obama's number falls between Thomas Wood and Paul Graziano, his number would have also been assigned on that day. Since information from the Social Security Administration is available for Thomas Wood, Paul Graziano, and Margaret Bossing, the SS-5 completed for social security number 042-68-4425, that was allegedly assigned to Barack Obama, will also be available.

40. On information and belief, Plaintiff asserts that it is not credible that, in 1977, Barack Obama traveled from Hawaii to Connecticut for a mandatory in-person interview after he applied for a Connecticut social security number. Barack Obama was then fifteen years old, living in Hawaii and enrolled in the tenth grade at Punahou Academy. Though the location of his birth is disputed, Barack Obama is alleged to have been born on August 4, 1961. (See attached Exhibit 15.)
41. Social Security Program Operations Manual System <https://secure.ssa.gov/apps10/> section: RM 10201.030 now states:

“Prior to June 25, 2011, the first three digits of the SSN represented the area number. The area number reflected the State as derived from the ZIP Code in the mailing address the number holder provided on the application for an original SSN card.” (See attached highlighted Exhibit 16.)
42. In contrast to Barack Obama's social security number, Barack Obama's half-sister, Maya Soetoro, was issued a social security number in Hawaii in 1985-1986 while living at the same addresses as Barack Obama. (See attached Exhibit 17a.) The year 1986 was the first time Barack Obama's name appeared with the Connecticut social security number. (See attached highlighted Exhibit 17b.)
43. Plaintiff has obtained a copy of an Hawaiian newspaper photograph of Barack Obama which places him in Hawaii in February, 1977 (see attached Exhibit 18) with the Punahou

Academy basketball team. February, 1977 was one month before the social security number Barack Obama uses was assigned.

44. Based on information and belief, Plaintiff asserts that in his book, Dreams from My Father, Barack Obama states that he was living in Hawaii from 1971 to 1979.
45. Plaintiff has obtained a photo of Barack Obama's "Choom Gang." Barack Obama described the "choom gang" in his book, Dreams from My Father, as the group with whom he used drugs. They are holding a "Class of 1979" cake, which appears to be a graduation cake. (See attached Exhibit 19.)

46. On information and belief, Plaintiff asserts that it is not credible that Barack Obama is using a properly issued, re-assigned social security number, because the Social Security Administration website states that numbers are never reissued. (See attached Exhibit 20.)

47. As an additional element of Plaintiff's investigation, Plaintiff went to the government public site which verifies Selective Service registration. Upon entering Barack Obama's name, date of birth and social security number, the following information was revealed: Barack Hussein Obama and social security \*\*\*-\*\*-4425. (See attached Exhibit 21.)  
  
Those are the last four numbers of the Connecticut social security number.
48. Further, to verify that Barack Obama was repeatedly using the Connecticut issued social security number 042-68-4425, Plaintiff obtained an affidavit regarding Obama's 2009 income tax return. (See attached Exhibit 22.) Barack Obama used the Connecticut social security number, 042-68-4425, on his 2009 income tax return.

49. Based on information and belief, Barack Obama entered Harvard University Law School in 1988. Plaintiff has obtained a copy of microfilm from the Massachusetts Bureau of Motor Vehicles (BMV) from that period. (See attached Exhibit 23a.) An alphabetical list of drivers on the microfilm includes Barack Obama using the Connecticut social security number, 042-68-4425. To verify the authenticity of the BMV microfilm, Plaintiff researched the other names on the list to ensure they were living in Massachusetts at the same time and had Massachusetts driver's licenses. (See attached Exhibit 23b.) Some information on other drivers has been obscured to maintain their privacy; however, Ignacio Obana is deceased and his information is included.
50. An unprecedented event occurred on April 3, 2009 when the Congressional Research Service, hereafter "CRS," presented to members of Congress a fourteen-page Memorandum. It was unlike any previously distributed. (See attached [page one only] highlighted: Exhibit 24.) The subject: "Qualifications for Office of President of the United States and Legal Challenges to the Eligibility of the Candidate [Emphasis added]." It specifically addressed the issue of Barack Obama as president and how Congress members were to respond to questions from any of the media about his eligibility under the Constitution. On page one, paragraph two, the last sentence reads: "Furthermore, there is no specific federal agency or office that 'vets' candidates for federal office as to qualifications or eligibility prior to election." (Emphasis added.) Therefore, as stated previously in this Complaint, neither any State, nor the Federal government, vets a presidential candidate.

51. On information and belief, as told to Plaintiff by a member of FL Congressman Bill Posey's office, CRS never before found it necessary to prepare such a document to justify a president's eligibility. The document was in response to serious questions being raised by some political figures, including Congressman Posey, about whether Barack Obama was properly holding the office of president.
52. Barack Obama has provided incorrect information in the past while alleging it was true. When he applied for his Attorney's Registration on December 17, 1991 he provided inaccurate information. In the section that asked for former names used, he entered: "None." (See attached Exhibit 25.) However, when Barack Obama's mother was married to Lolo Soetoro, Barack Obama was known as Barry Soetoro while he was registered in school in Indonesia and living there.
53. There were also questions raised about the documentation to include Barack Obama on the ballot in Hawaii. Hawaii Revised Statute 11-113(c)(1)(B) requires: "A statement that each candidate is legally qualified to serve under the provisions of the United States Constitution." (See attached highlighted Exhibit 26.) Candidate Barack Obama's ballot filing with the Hawaii Board of Election did **not** include that he was eligible under the U.S. Constitution or the Hawaii Constitution.
54. If a candidate did not meet the Constitutional requirement, an alternative option was available. A petition could be filed "containing the signatures of currently registered voters which constitute not less than one per cent of the votes cast in the State at the last presidential election." (See HRS 11-113 at <http://www.capitol.hawaii.gov>)

On information and belief, that petition was not provided to the Board of Elections, according to an employee representing Hawaii State Senator Sam Slom's office.

55. When the Democratic Party submitted its Official Certification of Nomination in 2008 to the State of Hawaii, Office of Elections, for Barack Obama, it removed the section that he was "legally qualified to serve under the provisions of the United States Constitution" to read "legally qualified to serve under the provisions of the national Democratic Parties...." (See attached highlighted Exhibit 27a.)
56. On information and belief, Plaintiff asserts that the Office of Elections, with concerns regarding Barack Obama's eligibility as a candidate, changed the wording on the document. The Hawaii Democratic Certifications of Nomination for the presidential elections for the years 2000 and 2004 contain the phrase: "...legally qualified to serve under the provisions of the United States Constitution..." (See attached highlighted Exhibits 27b and 27c.) That statement in the Hawaii Democratic Certification of Nomination in 2008 was replaced with: "... are legally qualified to serve under the provisions of the national Democratic Party..."
57. The 2008 Republican Party of Hawaii Certificate of Nomination reflects the candidates "...meeting the constitutional requirements...." (See attached highlighted Exhibit 28.) The Democratic Party filing does not include that wording.
58. The State of Ohio received similar documents. The Republican Certificate of Nominations notes that the candidates are "...meeting the constitutional requirements..." and the Democratic Official Certification of Nomination has candidates who "...were duly nominated...." (See attached highlighted Exhibits 29a and 29b.)

59. Candidates for the office of President of the United States are required under both U.S. and Ohio Constitutions to qualify before they can be placed on the ballot. Barack Obama has blatantly, and continuously used a fraudulent social security number and would be excluded as “qualified” for that reason. Defendant Husted, through this filing, has been made aware that the Democratic candidate Barack Obama has been using a fraudulent social security number, which would render Barack Obama ineligible under both the Ohio and U.S. Constitutions. Defendant Husted is duty bound by his oath to investigate these allegations.

60. Based on information and belief, Plaintiff asserts that Barack Obama is in violation of Ohio Revised Code 2913.49, which pertains to Identity Fraud:

(A) As used in this section, “personal identifying information” includes, but is not limited to, the following: the name, address, telephone number, driver’s license, driver’s license number, commercial driver’s license, commercial driver’s license number, state identification card, state identification card number, **social security card, social security number**, [Emphasis added] birth certificate, place of employment, employee identification number, mother’s maiden name, demand deposit account number, savings account number, money market account number, mutual fund account number, other financial account number, personal identification number, password, or credit card number of a living or dead individual.

(B) No person, without the express or implied consent of the other person, shall use, obtain, or possess any personal identifying information of another person with intent to do either of the following:

(1) Hold the person out to be the other person; (2) Represent the other person’s personal identifying information as the person’s own personal identifying information.” (See attached Exhibit 30.)

61. In Barack Obama’s position as President of the United States, a position Plaintiff alleges he obtained using, inter alia, a fraudulently obtained social security number, Barack



Obama is capable of signing laws that directly affect the future of the Plaintiff and all elderly Americans, including issues of healthcare and social security.

62. Plaintiff is a member of the class of American citizens seventy years of age and older and is at a decided disadvantage in the form of the adverse consequences to people in that age group under many of the proposed and already implemented dictates of Barack Obama. Those issues include, but are not limited to, threats of increased taxes, the ramifications of his Affordable Care Act, cuts to Medicare, and concerns regarding Social Security benefits.
63. Plaintiff apprehends that the acts taken by Barack Obama as President jeopardize the future of all elderly Americans because, as President of the United States, Barack Obama has the power not only to sign laws, but also to enforce those laws, in part, through, and as the result of, his use of an improperly and fraudulently obtained social security number.
64. Further, since Plaintiff is properly a candidate for President of the United States, which candidacy has been certified by Defendant John Husted, Plaintiff apprehends that she will be directly, concretely, personally, and continuously harmed as a direct and proximate result if Barack Obama's name appears on the Ohio ballot in November 2012, because the appearance of Barack Obama's name will result in votes for Mr. Obama that would otherwise go to the Plaintiff or other legally qualified candidates.

**RELIEF REQUESTED**

THEREFORE, Plaintiff prays that this Court,

1. Issue an order granting temporary and permanent injunctive relief prohibiting any action by Defendant Husted allowing the name of Barack Obama to appear as a candidate on any ballot in the State of Ohio for President of the United States in the November 2012 general election until it is determined that he is using a properly issued social security number; and
2. Issue a Writ of Mandamus to Defendant Husted to investigate Barack Obama's fraudulent use of a Connecticut social security number before he allows Barack Obama's name to appear on the Ohio ballot in the general election in November 2012; and
3. Retain jurisdiction of this action to ensure compliance with the Court's decrees: This Complaint is filed in the proper Jurisdiction and Venue since Geauga County is one of the eight-eight counties in which Defendant Husted has control over elections and where the Plaintiff resides; and
4. All such further relief as the Court may deem equitable, just and proper.

**3501.39 Grounds for rejection of petition or declaration of candidacy.**

(A) The secretary of state or a board of elections **shall** [Emphasis added] accept any petition described in section 3501.38 of the Revised Code unless one of the following occurs:

(1) A written protest against the petition or candidacy, naming specific objections, is filed, a hearing is held, and a determination is made by the election officials with whom the protest is filed that the petition is invalid, in accordance with any section of the Revised Code providing a protest procedure.

(2) A written protest against the petition or candidacy, naming specific objections, is filed, a hearing is held, and a determination is made by the election officials with whom the protest is filed that the petition violates any requirement established by law.

(3) The candidate's candidacy or the petition violates the requirements of this chapter, Chapter 3513. of the Revised Code, or any other requirements established by law.

(B) Except as otherwise provided in division (C) of this section or section 3513.052 of the Revised Code, a board of elections shall not invalidate any declaration of candidacy or nominating petition under division (A)(3) of this section after the sixtieth day prior to the election at which the candidate seeks nomination to office, if the candidate filed a declaration of candidacy, or election to office, if the candidate filed a nominating petition.

(C)(1) If a petition is filed for the nomination or election of a candidate in a charter municipal corporation with a filing deadline that occurs after the ninetieth day before the day of the election, a board of elections may invalidate the petition within fifteen days after the date of that filing deadline.

(2) If a petition for the nomination or election of a candidate is invalidated under division (C)(1) of this section, that person's name shall not appear on the ballots for any office for which the person's petition has been invalidated. If the ballots have already been prepared, the board of elections shall remove the name of that person from the ballots to the extent practicable in the time remaining before the election. If the name is not removed from the ballots before the day of the election, the votes for that person are void and shall not be counted.

Dear Mr. Brodnan,

Thank you for your letter. I appreciate you taking the time to express your concerns regarding the certification of presidential candidates' qualifications.

Ohio law provides that each political party can certify to my office the names of the two people that the party has selected to be its joint candidates for president and vice-president. While forms are filed in my office, I do not have the authority to review either the political party's selection process or the qualifications of the joint candidates. A challenge to the qualifications of joint candidates selected and certified to this office by a political party would have to be filed in court.

People also may seek to become joint candidates on the Ohio presidential ballot by filing with my office either nominating petition or declaration of intent to be joint write-in candidates. Both the petition and the declaration of intent include the candidates' statements that they are qualified to hold the offices of president and vice-president. The Secretary of State is required to accept those statements at face value unless a valid protest is filed that challenges the qualifications. If that happens, then my office conducts a protest hearing.

Again, thank you for your letter. Please let me know if I or my office can assist you further.

#### **111.24 Refusal of documents for filing or recording.**

(A) Notwithstanding any other provision of the Revised Code, if a person presents a document to the secretary of state for filing or recording, the secretary of state may refuse to accept the document for filing or recording if the document is not required or authorized to be filed or recorded with the secretary of state or the secretary of state has reasonable cause to believe the document is materially false or fraudulent. This division does not create a duty upon the secretary of state to inspect, evaluate, or investigate a document that is presented for filing or recording.

(B) If the secretary of state, pursuant to division (A) of this section, refuses to accept a document for filing or recording, the person who presented the document to the secretary of state may commence an action in or apply for an order from the court of claims to require the secretary of state to accept the document for filing or recording. If the court determines that the document is appropriate for filing or recording, it shall order the secretary of state to accept the document for that purpose.

(C) If the secretary of state, acting under this section in a manner that does not subject the secretary of state to personal liability under section 9.86 of the Revised Code, improperly refuses to accept a document for filing or recording, the secretary of state shall not be personally liable on account of the improper refusal and the sureties that issued the bond shall not have a right of subrogation against the secretary of state on account of a claim made on the secretary of state's bond as a result of the improper refusal.

Dear Ms. Daniels:

This letter serves as certification by Secretary of State Jon Husted of your Declaration of Intent to be Write-in Candidates for the office of president and vice-president of the United States at the November 6, 2012, general election.

I am pleased to inform you that your name, and the name of Jerry A. Veneskey (as your candidate for vice-president), will be certified to the 2012 General Election Ballot for the offices of president and vice-president.

However, there are two (2) important points to note in connection with your declaration of intent. First, you filed a list of twenty (20) electors with your declaration. As only eighteen (18) electors are required, we will consider the first eighteen (18) electors listed to be the electors who would represent you in the Electoral College.

More importantly, though, you should know that, because both you and Mr. Veneskey are both residents of Ohio, the "habitation clause" of the 12<sup>th</sup> Amendment to the U.S. Constitution could severely limit your joint candidacy in Ohio.

The "habitation clause" of the 12<sup>th</sup> Amendment reads as follows:

*The Electors shall meet in their respective states, and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves;*

While nothing in the U.S. Constitution prohibits candidates for president and vice-president from being from a single state, the "habitation clause" provides that electors (i.e., members of the Electoral College from a particular state) may not vote for a President from their state and a Vice President also from their state. Accordingly, a member of the Electoral College would be unable to cast a vote for Mr. Veneskey.

### **3501.06 County board of elections.**

There shall be in each county of the state a board of elections consisting of four qualified electors of the county, who shall be appointed by the secretary of state, as the secretary's representatives, to serve for the term of four years. On the first day of March in even-numbered years the secretary of state shall appoint two of such board members, one of whom shall be from the political party which cast the highest number of votes for the office of governor at the most recent regular state election, and the other shall be from the political party which cast the next highest number of votes for the office of governor at such election. All vacancies filled for unexpired terms and all appointments to new terms shall be made from the political party to which the vacating or outgoing member belonged, unless there is a third political party which cast a greater number of votes in the state at the most recent regular state election for the office of governor than did the party to which the retiring member belonged, in which event the vacancy shall be filled from such third party.

### **3501.13 [First of Two Versions] Duties of director.**

(A) The director of the board of elections shall keep a full and true record of the proceedings of the board and of all moneys received and expended; file and preserve in the board's office all orders and records pertaining to the administration of registrations, primaries, and elections; receive and have the custody of all books, papers, and property belonging to the board; and perform other duties in connection with the office of director and the proper conduct of elections as the board determines.

(B) Before entering upon the duties of the office, the director shall subscribe to an oath that the director will support the Constitution of the United States and the Ohio Constitution, perform all the duties of the office to the best of the director's ability, enforce the election laws, and preserve all records, documents, and other property pertaining to the conduct of elections placed in the director's custody.

(C) The director may administer oaths to persons required by law to file certificates or other papers with the board, to judges of elections, to witnesses who are called to testify before the board, and to voters filling out blanks at the board's offices. Except as otherwise provided by state or federal law, the records of the board and papers and books filed in its office are public records and open to inspection under such reasonable regulations as shall be established by the board. The following notice shall be posted in a prominent place at each board office:

"Except as otherwise provided by state or federal law, records filed in this office of the board of elections are open to public inspection during normal office hours, pursuant to the following reasonable regulations: (the board shall here list its regulations). Whoever prohibits any person from inspecting the public records of this board is subject to the penalties of section 3599.161 of the Revised Code."

(D) Upon receipt of a written declaration of intent to retire as provided for in section 145.38 of the Revised Code, the director shall provide a copy to each member of the board of elections.

**3501.04 Secretary of state is chief election officer.**

The secretary of state is the chief election officer of the state, with such powers and duties relating to the registration of voters and the conduct of elections as are prescribed in Title XXXV [35] of the Revised Code. He shall perform these duties, in addition to other duties imposed upon him by law, without additional compensation.

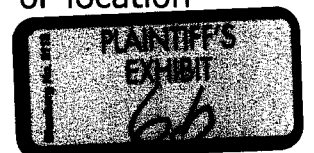
**3501.18 [First of Two Versions] Division of political subdivision into precincts.**

(A) The board of elections may divide a political subdivision within its jurisdiction into precincts, establish, define, divide, rearrange, and combine the several election precincts within its jurisdiction, and change the location of the polling place for each precinct when it is necessary to maintain the requirements as to the number of voters in a precinct and to provide for the convenience of the voters and the proper conduct of elections. No change in the number of precincts or in precinct boundaries shall be made during the twenty-five days immediately preceding a primary or general election or between the first day of January and the day on which the members of county central committees are elected in the years in which those committees are elected. Except as otherwise provided in division (C) of this section, each precinct shall contain a number of electors, not to exceed one thousand four hundred, that the board of elections determines to be a reasonable number after taking into consideration the type and amount of available equipment, prior voter turnout, the size and location of each selected polling place, available parking, availability of an adequate number of poll workers, and handicap accessibility and other accessibility to the polling place.

If the board changes the boundaries of a precinct after the filing of a local option election petition pursuant to sections 4301.32 to 4301.41, 4303.29, or 4305.14 of the Revised Code that calls for a local option election to be held in that precinct, the local option election shall be held in the area that constituted the precinct at the time the local option petition was filed, regardless of the change in the boundaries.

If the board changes the boundaries of a precinct in order to meet the requirements of division (B)(1) of this section in a manner that causes a member of a county central committee to no longer qualify as a representative of an election precinct in the county, of a ward of a city in the county, or of a township in the county, the member shall continue to represent the precinct, ward, or township for the remainder of the member's term, regardless of the change in boundaries.

In an emergency, the board may provide more than one polling place in a precinct. In order to provide for the convenience of the voters, the board may locate polling places for voting or registration outside the boundaries of precincts, provided that the nearest public school or public building shall be used if the board determines it to be available and suitable for use as a polling place. Except in an emergency, no change in the number or location



of the polling places in a precinct shall be made during the twenty-five days immediately preceding a primary or general election.

Electors who have failed to respond within thirty days to any confirmation notice shall not be counted in determining the size of any precinct under this section.

(B)(1) Except as otherwise provided in division (B)(2) of this section, a board of elections shall determine all precinct boundaries using geographical units used by the United States department of commerce, bureau of the census, in reporting the decennial census of Ohio.

(2) The board of elections may apply to the secretary of state for a waiver from the requirement of division (B)(1) of this section when it is not feasible to comply with that requirement because of unusual physical boundaries or residential development practices that would cause unusual hardship for voters. The board shall identify the affected precincts and census units, explain the reason for the waiver request, and include a map illustrating where the census units will be split because of the requested waiver. If the secretary of state approves the waiver and so notifies the board of elections in writing, the board may change a precinct boundary as necessary under this section, notwithstanding the requirement in division (B)(1) of this section.

(C) The board of elections may apply to the secretary of state for a waiver from the requirement of division (A) of this section regarding the number of electors in a precinct when the use of geographical units used by the United States department of commerce, bureau of the census, will cause a precinct to contain more than one thousand four hundred electors. The board shall identify the affected precincts and census units, explain the reason for the waiver request, and include a map illustrating where census units will be split because of the requested waiver. If the secretary of state approves the waiver and so notifies the board of elections in writing, the board may change a precinct boundary as necessary to meet the requirements of division (B)(1) of this section.

**TITLE II. COMMENCEMENT OF ACTION AND VENUE;  
SERVICE OF PROCESS; SERVICE AND FILING OF  
PLEADINGS AND OTHER PAPERS SUBSEQUENT  
TO THE ORIGINAL COMPLAINT; TIME**

**RULE 3. Commencement of Action; Venue**

**(A) Commencement.** A civil action is commenced by filing a complaint with the court, if service is obtained within one year from such filing upon a named defendant, or upon an incorrectly named defendant whose name is later corrected pursuant to Civ.R. 15(C), or upon a defendant identified by a fictitious name whose name is later corrected pursuant to Civ.R. 15(D).

**(B) Venue: where proper.** Any action may be venued, commenced, and decided in any court in any county. When applied to county and municipal courts, "county," as used in this rule, shall be construed, where appropriate, as the territorial limits of those courts. Proper venue lies in any one or more of the following counties:

- (1) The county in which the defendant resides;
- (2) The county in which the defendant has his or her principal place of business;
- (3) A county in which the defendant conducted activity that gave rise to the claim for relief;
- (4) A county in which a public officer maintains his or her principal office if suit is brought against the officer in the officer's official capacity;
- (5) A county in which the property, or any part of the property, is situated if the subject of the action is real property or tangible personal property;
- (6) The county in which all or part of the claim for relief arose; or, if the claim for relief arose upon a river, other watercourse, or a road, that is the boundary of the state, or of two or more counties, in any county bordering on the river, watercourse, or road, and opposite to the place where the claim for relief arose;
- (7) In actions described in Civ.R. 4.3, in the county where plaintiff resides;
- (8) In an action against an executor, administrator, guardian, or trustee, in the county in which the executor, administrator, guardian, or trustee was appointed;
- (9) In actions for divorce, annulment, or legal separation, in the county in which the plaintiff is and has been a resident for at least ninety days immediately preceding the filing of the complaint;

## Structure of Social Security Numbers



A Social Security Number (SSN) consists of nine digits, commonly written as three fields separated by hyphens: AAA-GG-SSSS. The first three-digit field is called the "area number". The central, two-digit field is called the "group number". The final, four-digit field is called the "serial number".

The process of assigning numbers has been changed at least twice. Until 1965, only half the group numbers were used. Before 1972, numbers were assigned by field offices; since 1972, they have all been assigned by the central office. The order in which numbers were assigned was changed in the 1972 transition. There may have been other changes, but it's difficult to get information on how things used to be done.

### Area Numbers

The area numbers are assigned to geographical locations. They were originally assigned the same way that zip codes were later assigned (in particular, area numbers increase from east to west across the continental US as do the ZIP codes). Most area numbers were assigned according to state (or territorial) boundaries, although the series 700-729 was assigned to railroad workers regardless of location (this series of area numbers was discontinued in 1964 and is no longer used for new SSNs). Area numbers assigned prior to 1972 are an indication of the SSA office which originally issued the SSN. Since 1972 the area number in SSNs corresponds to the residence address given by the applicant on the application for the SSN.

In many regions the original range of area number assignments was eventually exhausted as population grew. The original area number assignments have been augmented as required. All of the original assignments were less than 585 (except for the 700-729 railroad worker series mentioned above). Area numbers of "000" have never been issued.

800-999 not valid SSNs. Some sources have claimed that numbers above 900 were used when some state programs were converted to federal control, but current SSA documents claim no numbers above 799 have ever been used.

## Group Numbers

The group number is not related to geography but rather to the order in which SSNs are issued for a particular area. Before 1965, only half the group numbers were used: odd numbers were used below 10 and even numbers were used above 9. In 1965 the system was changed so assignments continued with the low even numbers and the high odd numbers. So, group numbers for each area number are assigned in the following order:

1. Odd numbers, 01 to 09
2. Even numbers, 10 to 98
3. Even numbers, 02 to 08
4. Odd numbers, 11 to 99

Group codes of "00" aren't assigned

In each region, all possible area numbers are assigned with each group number before using the next group number. This means the group numbers can be used to find a chronological ordering of SSNs within a region. When new group numbers are assigned to a state, the old numbers are usually used up first.

SSA publishes a list every month of the highest group assigned for each SSN Area. For example, if the highest group assigned for area 999 is 72, then we know that the number 999-04-1234 is an invalid number because even Groups under 9 have not yet been assigned.

## Serial Numbers

Serial numbers are assigned in chronological order within each area and group number as the applications are processed. Serial number "0000" is never used. Before 1965, when number assignment was transferred from field offices to the central office, serial numbers may have been assigned in a strange order. (Some sources claim that 2000 and 7000 series numbers were assigned out of order. That no longer seems to be the case.) Currently, the serial numbers are assigned in strictly increasing order with each area and group combination.

## **Invalid SSNs**

Any SSN conforming to one of the following criteria is an invalid number:

1. Any field all zeroes (no field of zeroes is ever assigned).
2. First three digits above 740

A pamphlet entitled "The Social Security Number" (Pub. No. 05-10633) provides an explanation of the SSN's structure and the method of assigning and validating Social Security numbers.

This description of the structure of the Social Security Number is based on messages written by Jerry Crow and Barbara Bennett. The information has been verified by its correspondence to the SSA's Program Operations Manual System (POMS) Part 01, Chapter 001, subchapter 01, which can be found at Federal Depository Libraries. (SSA Pub. No. 68-0100201.)

3. I hereby certify that on October 19, 2010 under FOIA, I requested the SS-5 form (Social Security Number application) for Wood, Thomas, 042-68-4424, Birth: 15 Jul 1962, Death: Jul 1981. On December 9, 2010, I received a letter from Dawn Wiggins, Freedom of Information Officer dated November 30, 2010 with a virtually unreadable computer printout attached, instead of the SS-5 form. On January 8, 2011, I reordered Thomas Wood's SS-5, this time as a Certified copy and paid #37.00. On Feb 5, 2011, I received a letter from Mona Finch, Freedom of Information Officer, dated February 2, 2011, again with a barely readable computer printout, instead of the SS-5 form that I had ordered. On February 6, 2011, I filed the following complaint on the following website:

Feb 6, 2011:

On Feb 5, 2011, I received from SSA a barely readable computer print for Thomas Wood, Birth: 15 Jul 1962, Death: Jul 1981.

My complaint is that I ordered and paid for a Certified SS-5 copy, which should have included a copy of the actual SS-5 form and the Certification letter signed by Kathryn E. Fox with red ribbons and the SSA gold seal and the numident computer printout (I checked this box: Certification is required, adds \$10.00 to fee) and I paid a total of \$37.00. I did not receive a copy of the actual SS-5 form, nor the Certification letter with ribbons and seal, nor the numident printout.

Please investigate this discrepancy in the document that SSA mailed to me. Please forward to me a copy of actual SS-5 form, Certification letter, and the numident for Thomas Wood, which I paid for.

On March 11, 2011, I received Thomas Louis Wood's Certified SS-5, true and complete copies, from Georgiana Wilson-Johnson, Deputy Director, Division of Earnings Record Operations, dated February 28, 2011, that I had ordered on January 8, 2011.


4. The original documents supplied to me by the Social Security Administration remained in my custody until March 14, 2011. On which day, I made complete copies of those documents referencing Thomas Louis Wood, said document copies remained in my custody, and are now attached to this affidavit. ## RM 10201.030 Structure of the Social Security Number (SSN)

The SSN consists of nine digits, separated into three groups by hyphens (i.e., 000-00-0000). This section contains a description of what each group of numbers represented in the Social Security Number (SSN), prior to June 25, 2011. Beginning June 25, 2011 forward, this structure is no longer of any significance.

**NOTE:** Information about the structure of the SSN is not restricted. Field offices (FOs) may respond to inquiries about the significance of the SSN structure and State allocations of area numbers.

### A. SSN area number

Prior to June 25, 2011, the first three digits of the SSN represented the area number. The area number reflected the State as derived from the ZIP Code in the mailing address the number holder provided on the application for an original SSN card.

### B. SSN group number

Prior to June 25, 2011, the middle two digits of the SSN represented the group number. The group number ranged from 01 to 99. For administrative reasons, we assigned group numbers in the following sequence:

1. odd numbers from 01 through 09;
2. even numbers from 10 through 98;
3. even numbers from 02 through 08; and finally,
4. odd numbers 11 through 99.

### C. SSN serial number

Prior to June 25, 2011, the last four digits of the SSN represented the serial number. The serial number represents a straight numerical series of numbers from 0001-9999 within each group.

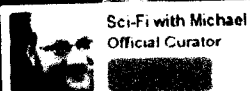

3. I downloaded this 65-page pdf file on my computer. I observed that all information about the president's and the first lady's social security numbers were redacted. All blocks or spaces for social security numbers were blank, or "white-out."
4. I submit Exhibit A (attached herewith, page 43 part of 2009 Form 1040) Form 709 U.S. Gift Tax Return of Pres. Barack Obama. The space for his social security number is redacted or blank.
5. I submit too Exhibit B (attached herewith, page 49 part of 2009 Form 1040) Form 709 U.S. Gift Tax Return of First Lady Michelle Obama. The space for her social security number is redacted or blank.
6. Then through Adobe Illustrator software, I opened Exhibit A and B and found that these two pdf files have two layers each, not just one layer. When the top layer is turned off or dragged away, the social security numbers of both persons are revealed.
7. I submit Exhibit A1 (attached herewith) Form 709 U.S. Gift Tax Return of Pres. Barack Obama with his social security number revealed. The following information are revealed:
  1. Barack Obama's SSN. 042-68-4425
  2. Michelle Obama's SSN 350-60 ;
  3. An initial MLO on the side of Form 709
  4. A 1/4 inch dark square with notation on it.

9. It is apparent that the tax preparer for Forms 709 of Pres. Obama may have forgotten to lock or flatten the covering top layers before posting them on the Internet. I later noticed that after April 15, 2010, the pdf file posted at the White House has been modified. The top layers on President Obama's Income Tax Return have been locked or flattened and could no longer be dragged out. His SSN and his wife's SSN were no longer visible.

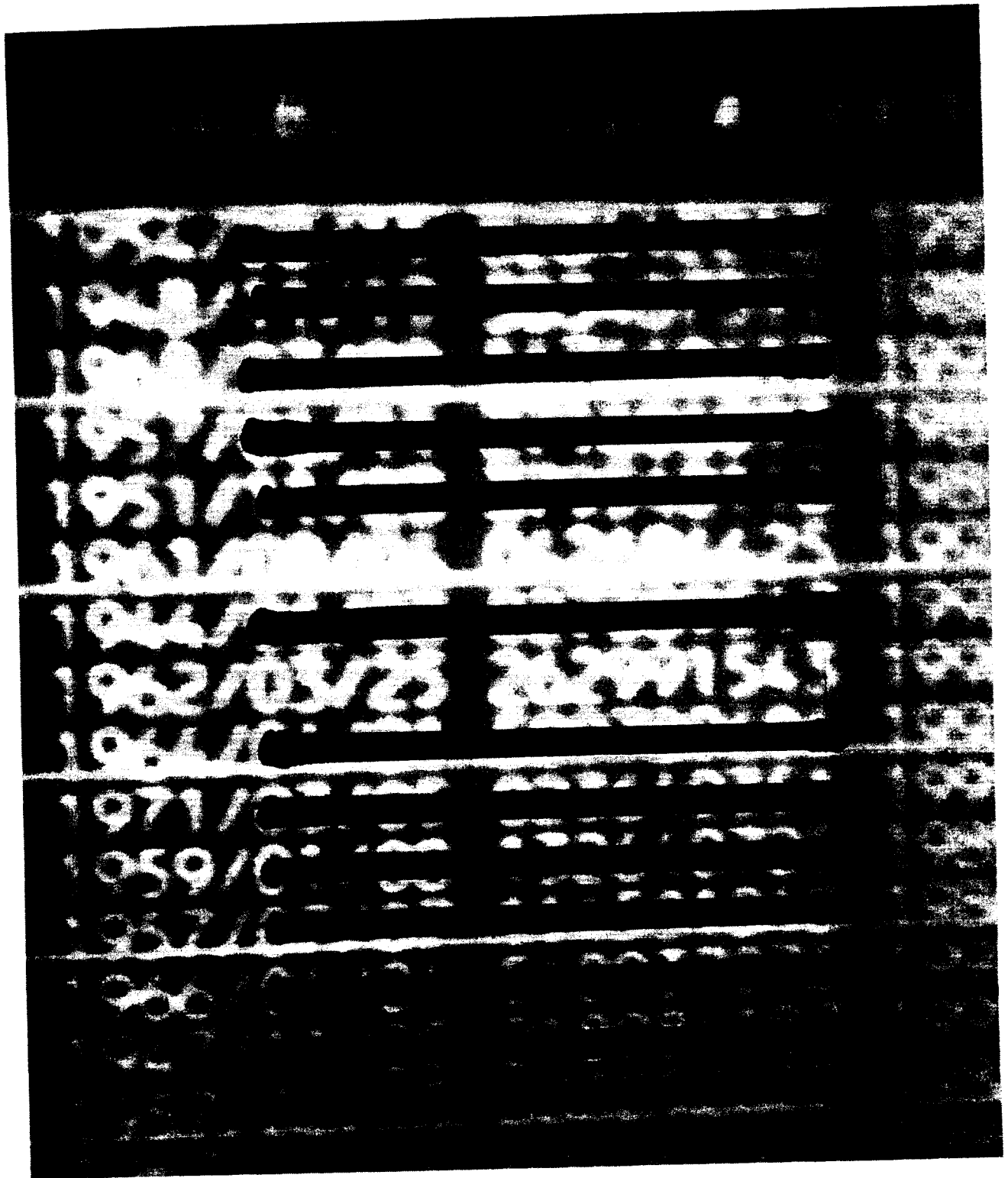

**Subject** Qualifications for the Office of President of the United States and Legal Challenges to the Eligibility of a Candidate

**This memorandum was prepared to enable distribution to more than one congressional office.**

This memorandum addresses inquiries from congressional offices regarding the constitutional qualifications for the office of President of the United States, and the issue of challenges concerning specifically the questioning of President Obama's "natural born citizenship" status.<sup>1</sup> Many of the inquiries have questioned why then-Senator, and now President, Obama has not had to produce an original, so-called "long" version of a "birth certificate" from the State of Hawaii, how federal candidates are "vetted" for qualifications generally, and have asked for an assessment of the various allegations and claims of non-eligibility status.

Concerning the production or release of an original birth certificate, it should be noted that there is no federal law, regulation, rule, guideline, or requirement that a candidate for federal office produce his or her original birth certificate, or a certified copy of the record of live birth, to any official of the United States Government; nor is there a requirement for federal candidates to publicly release such personal record or documentation.<sup>2</sup> Furthermore, there is no specific federal agency or office that "vets" candidates for federal office as to qualifications or eligibility prior to election.<sup>3</sup>

The mechanics of elections of federal officials within the several states are administered under state law.<sup>4</sup> The quadrennial presidential election, although required since 1845 to be held on the same day in each

<sup>1</sup> The standing qualifications to be President of the United States, at Article II, Section 1, clause 5, of the Constitution provide that one must be at least 35 years old, a resident "within the United States" for 14 years, and a "natural born Citizen."

<sup>2</sup> In addition to the "natural born Citizen" requirement for President, a United States Senator must be a "citizen" of the United States for nine years (Art. I, Sec. 3, cl. 3), and a United States Representative must be a "citizen" for seven years (Art. I, Sec. 2, cl. 2). No general requirement exists for candidates to the United States Senate or House of Representatives to produce an original, or a certified copy of a birth certificate.

<sup>3</sup> The Federal Election Commission is authorized by law to administer and seek compliance with the *campaign finance* provisions of federal law for candidates to federal office, and to administer and seek compliance with the provisions for public financing of the nomination and election of candidates for President, but has no duties or responsibilities with respect to judging or vetting qualifications or eligibility of candidates to federal office. 2 U.S.C. § 437c.

<sup>4</sup> Article II, Section 1, cl. 2, delegates authority to the state legislatures to direct the manner of appointment of electors for President; and Article I, Section 4, cl. 1, delegates to the state legislatures the initial authority for the "Times, Places and Manner" of elections to Congress, with a residual authority in Congress to make such regulations.

**§11-113 Presidential ballots.** (a) In presidential elections, the names of the candidates for president and vice president shall be used on the ballot in lieu of the names of the presidential electors, and the votes cast for president and vice president of each political party shall be counted for the presidential electors and alternates nominated by each political party.

(b) A "national party" as used in this section shall mean a party established and admitted to the ballot in at least one state other than Hawaii or one which is determined by the chief election officer to be making a bona fide effort to become a national party. If there is no national party or the national and state parties or factions in either the national or state party do not agree on the presidential and vice presidential candidates, the chief election officer may determine which candidates' names shall be placed on the ballot or may leave the candidates' names off the ballot completely.

(c) All candidates for president and vice president of the United States shall be qualified for inclusion on the general election ballot under either of the following procedures:

(1) In the case of candidates of political parties that have been qualified to place candidates on the primary and general election ballots, the appropriate official of those parties shall file a sworn application with the chief election officer not later than 4:30 p.m. on the sixtieth day prior to the general election, which shall include:

- (A) The name and address of each of the two candidates;
- (B) A statement that each candidate is legally qualified to serve under the provisions of the United States Constitution; and
- (C) A statement that the candidates are the duly chosen candidates of both the state and the national party, giving the time, place, and manner of the selection; and

(2) In the case of candidates of parties or groups not qualified to place candidates on the primary or general election ballots, the person desiring to place the names on the general election ballot shall file with the chief election officer not later than 4:30 p.m. on the ninetieth day prior to the general election:

- (A) A sworn application that shall include the information required under paragraph (1) (A), (B), and (C), where applicable; and
- (B) A petition that shall be upon the form prescribed and provided by the chief election officer containing the signatures of currently registered voters which constitute not less



than one per cent of the votes cast in the State at the last presidential election. The petition shall contain the names of the candidates, a statement that the persons signing intend to support those candidates, the address of each signatory, the date of the signer's signature, and other information as determined by the chief election officer.

Prior to being issued the petition form, the person desiring to place the names on the general election ballot shall submit a notarized statement from each prospective candidate of that prospective candidate's intent to be a candidate for president or vice president of the United States on the general election ballot of the State of Hawaii. The statements by a prospective candidate for vice president may be withdrawn by that prospective candidate and an alternative candidate for vice president may be substituted any time prior to the notification of qualification or disqualification provided in subsection (d). Any substitutions shall be accompanied by a notice of substitution satisfying subparagraph (A), a statement of intent as required by this paragraph, and a letter by the candidate for president endorsing the substitute candidate for vice president. Upon receipt of a notice of substitution and all other required documents, the substitute shall replace the original candidate for vice president on the general election ballot. The petitions issued in the names of the original candidates will remain valid for the purposes of this section.

(d) Each applicant and the candidates named, shall be notified in writing of the applicant's or candidate's eligibility or disqualification for placement on the ballot not later than 4:30 p.m. on the tenth business day after filing. The chief election officer may extend the notification period up to an additional five business days, if the applicants and candidates are provided with notice of the extension and the reasons therefore.

(e) If the applicant, or any other party, individual, or group with a candidate on the presidential ballot, objects to the finding of eligibility or disqualification the person may, not later than 4:30 p.m. on the fifth day after the finding, file a request in writing with the chief election officer for a hearing on the question. A hearing shall be called not later than 4:30 p.m. on the tenth day after the receipt of the request and shall be conducted in accord with chapter 91. A decision shall be issued not later than 4:30 p.m. on the fifth day after the conclusion of the hearing. ## **2913.49 Identity fraud.**

(A) As used in this section, "personal identifying information" includes, but is not limited to, the following: the name, address, telephone number, driver's license, driver's license number, commercial driver's license, commercial driver's license number, state identification card, state identification card number, social security card, social security number, birth certificate, place of employment, employee identification number, mother's maiden name, demand deposit account number, savings account number, money market account number, mutual fund account number, other financial account number, personal identification number, password, or credit card number of a living or dead individual.

(B) No person, without the express or implied consent of the other person, shall use, obtain, or possess any personal identifying information of another person with intent to do either of the following:

- (1) Hold the person out to be the other person;
- (2) Represent the other person's personal identifying information as the person's own personal identifying information.
