INSTRUCTIONS
RESPECTING MY PETITION TO APPEAR BEFORE
THE TUESDAY, 18 JULY TERM
OF THE McMINN COUNTY GRAND JURY

Mr. Larry Wallace and Assistant Court Clerk Sherry Anderson represent physical, personal threats. DIRECT WALLACE AND ANDERSON TO STAND CLEAR OF ME. STAND FAR AWAY. WALLACE and ANDERSON are to MAKE NO CONTACT, by any description, with me.

Mr. Larry Wallace is named and accused as a criminal in my Petition. Mr. Wallace must be removed, as a matter of law, from all grand jury proceedings wherein my criminal accusations against Mr. Wallace are discussed, deliberated and otherwise come under scrutiny.

Mr. Wallace's replacement as foreman to the grand jury must be made from among the members of the grand jury themselves. All grand jury members must be randomly selected into the grand jury membership.

All members of the 18 July 2017 McMinn County Grand Jury Term must have no connections and no associations, by whatever description, with Messrs. Larry Wallace, Jeffery Lane Cunningham or McMinn County Sheriff Joe Guy.

All members of the 18 July 2017 McMinn County Grand Jury Term must have no connections and no associations, by whatever description, with Athens Bancshares, Incorporated, or with Athens Federal Community Bank (formerly known as Athens Federal Savings and Loan).

All members of the 18 July 2017 McMinn County Grand Jury Term must have no connections and no associations, by whatever description, with myself. Qualified grand jury members must not know

me, must not know anything about my background, my accusations, my case. They must not know me.

Based upon the legal requirements prohibiting certain persons identified above from membership on the 18 July 2017 Term of the McMinn County Grand Jury, in the event additional grand jurors are required, you are to call upon Captain Rob Davis, Interim Chief of Police for Athens, Tennessee, to cause by-stander jurors to be found from the community-at-large and delivered to the Court. The McMinn County Tennessee Sheriff's Department is compromised and criminally complicit as stated in my Petition's proffer of expected testimony.

As a matter of law, I demand to select, by name, two of the three grand jurors who are to consider my request to appear before the full grand jury. In support of making my selection I wish to be given a list of the names of all persons qualified to serve. I wish to know, from among the eligible grand jury population, who hold high school diplomas (not GED'S or diploma equivalents) and who hold college degrees or post-graduate degrees (Masters or Doctorate degrees of any discipline).

Today I anticipate being ushered into the grand jury setting last after all others, only after the grand jury will have had hours of work behind them. They will be fatigued. I must be allowed to begin, then called back singularly to address the members once rested and refreshed.

It will take grand jury members a number of hours just to read my documentation once copies are provided to them.

A copy of the largest document package is available to use to copy. All pages are loose. No staples; no binder clips. The copy I'm able to offer for reproduction is to be returned to me once replication is complete.

Grand jury members will need my assistance and guidance as they study the document package I present today.

Once I make first contact with the 18 July 2017 Term of the McMinn County, additional meetings will be required and are to be scheduled so as to allow an opportunity for me to make my full presentation.

I do not bring my computer equipment or computer equipment with me today. It's not prudent. For future planning, I need to know if wireless technology is available in the courthouse and if there are sufficient power outlets.

My business today, and hereafter, is with a properly constituted, constitutionally assembled, constitutionally recognized and constitutionally operating grand jury. No attorney is allowed to be present in the room during my presentations.

Should at any time in the processing and proceedings of my criminal complaints, outside of my grand jury presentations, the grand jury requires the assistance of a licensed attorney, assign elected 10th Judicial District Public Defender Richard Hughes the duty of picking an attorney randomly from the community-at-large or randomly from Hughes' office.

No attorney called to assist the grand jury can have any prior association with me, or my case. The assigned attorney must not know me.

Richard Hughes is disqualified from assisting the grand jury entity due to Hughes prior interactions with myself.

No attorney from Tennessee's 10th Judicial District is to participate in any part of my cause or have any contact with this case. This specifically includes 10th Judicial District Attorney General Stephen D. Crump. Attorney Crump is named as a criminal actor in my sworn statements. Crump's predecessor, Robert Steven Bebb, is also named. Many 10th Judicial District attorneys, past and present, are named as outlaws in the criminal adventures I can describe.
