Thank you for contacting the Morton Police Department with your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.

On July 29, 2013 our agency received a request from you for information pertaining to incident # (13-096695, and a copy of the phone conversation between Ofc. Herman, and the Washington DC Capital Police).

Your request for incident # 13-096695 is granted. Your request for a copy of the phone conversation between Ofc. Herman, and the Capital Police is denied under section 5 ILCS 140/7 (1)(d)(v) and 5 ILCS 140/7 (1)(d)(vii) of the Freedom of Information Act. Redactions were made under section 5 ILCS 140/2(c-5), exemption 7(1)(b) of the Freedom of Information Act pertaining to private information.


