6. I command the production of the citation found in Tennessee State law defining the phrase “substantial citizen of [a] County.”

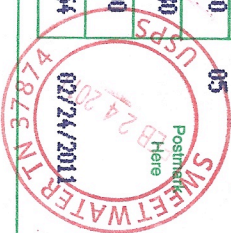

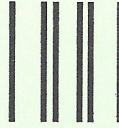
