19 court of record declare under penalty of perjury under the law of the United
20 States of America that the foregoing is true and correct.
- 21 2. We are the Plaintiffs in the above entitled case, and in support of our motion to
22 proceed without being required to prepay fees, costs or give security for the
23 filing of complaint, the making and certifying copies, the U.S, Marshal's to give
24 notice, the reporter's daily fee, and the preparing and certifying of the transcript
25 should there be an appeal.

- 19 9. We are financially supported solely by the small contributions of friends, and
20 these gifts amount to no more than \$100 USD a week.

- 22 10. We do not have money in a checking or savings account, and we do not own any
23 real estate, stocks, bonds, notes, automobiles or any other valuable property.

- 25 11. The last year we filed an income tax return was on or about 2007.

- 27 12. Our last tax return reflected approximately \$15,000 USD.
