Dear Judge Jeanine Pirro,

I write you as an unashamed born again Bible believing Christian and a natural born American Citizen. I make this appeal to your conscience and your heart, and I pray the Lord Jesus Christ will help you to understand the gravity of what it is I bring before you, constraining you to act in righteousness with honor and respect to the truth. The Lord allowed you to be a justice of the law and with that great power is great responsibility: *"for unto whomsoever much is given, of him shall be much required."*¹

I will be candid and honest, doing my best to be as brief in summation as I can.
