OFFICIAL VERSION:

WALTER FRANCIS FITZPATRICK III WAS INDICTED BY THE MARCH 2014 TERM OF THE MCMINN COUNTY GRAND JURY AND CHARGED WITH HARASSMENT, AGGRAVATED PERJURY, STALKING AND EXTORTION.

THE CASE WENT TO TRIAL, AND ON JUNE 24, 2014 A MCMINN COUNTY JURY FOUND THE DEFENDANT GUILTY OF AGGRAVATED PERJURY, AND EXTORTION. THE SAME DAY, A MCMINN COUNTY JURY FOUND THE DEFENDANT NOT GUILTY OF THE CHARGE OF HARASSMENT. ADDITIONALLY, THE STATE OF TENNESSEE DISMISSED THE CHARGE OF STALKING ON JUNE 24, 2014. THE SAME DAY, A PRE-SENTENCE INVESTIGATIVE RECORD WAS ORDERED BY JUDGE BLACKWOOD, AND SENTENCING HEARING WAS SET FOR AUGUST 18, 2014 IN MCMINN COUNTY CRIMINAL COURT.

THIS INVESTIGATION WAS PREDICATED BY AN INVESTIGATION REQUEST BY DISTRICT ATTORNEY GENERAL R. STEVEN BEBB.

ON FEBRUARY 14, 2014 WALTER F. FITZPATRICK GOES TO THE MCMINN COUNTY, CIRCUIT COURT CLERKS OFFICE AND FILES FOR A PETITION FOR ORDER OF

AGENCY STATEMENT:

HEARING AGAINST JEFF CUNNINGHAM WHO IS THE GRAND JURY FOREMAN OF MCMINN COUNTY. MR. FITZPATRICK STATES IN THE PETITION THAT ' MR. CUNNINGHAM HAS PHYSICALLY BLOCKED HIM FROM APPEARING BEFORE THE MCMINN COUNTY GRAND JURY. MR. FITZPATRICK ALSO PROVIDES AN ATTACHMENT TO THE PETITION THAT LIST HIS MEMORANDUM OF COMPLAINT. A COPY OF A LETTER TO THE BOARD OF PROFESSIONAL RESPONSIBILITY OF THE SUPREME COURT OF TENNESSEE ASKING FOR THE PERMANENT LAW LICENSE REVOCATION AND DISBARMENT OF MR. CUNNINGHAM IS INCLUDED. HE ALSO STATES THAT MR. CUNNINGHAM IS ILLEGALLY AND IMPROPERLY IMPANELED AS THE GRAND JURY FOREMAN. MR. FITZPATRICK GIVES A LIST OF VARIOUS CRIMINAL ACTS THAT HE BELIEVES HAVE OCCURRED, OFFICIAL MISCONDUCT OFFICIAL OPPRESSION, TAMPERING WITH OR FABRICATING EVIDENCE, COERCION OF A WITNESS, COERCION OF JUROR , IMPROPER INFLUENCE OF A JUROR AND PERJURY. MR. FITZPATRICK STATES IN HIS COMPLAINT THAT "MR. CUNNINGHAM IS NOT A JUROR! MR. CUNNINGHAM, TRAINED AS AN ATTORNEY, KNOWS HE IS VIOLENTLY BREAKING THE LAW. MR. CUNNINGHAM'S CONTINUED PRESENCE IN THE GRAND JURY ROOM AS THESE CHARGES AGAINST HIM ARE READ AND CONSIDERED IS INTOLERABLE." CHANCERY COURT JUDGE JERRI BRYANT DENIED THE FEBRUARY 14, 2014 PETITION.

ON FEBRUARY 18, 2014, THE MCMINN COUNTY GRAND JURY CONVENES FOR ITS MONTHLY SESSION. MR. FITZPATRICK IS PRESENT IN THE HALLWAY OUTSIDE THE GRAND JURY ROOM. MR. CUNNINGHAM SEES MR. FITZPATRICK IN THE HALLWAY AND ADVISES HIM THAT THE GRAND JURY WILL NOT HEAR FROM HIM. MCMINN COUNTY SHERIFF DEPARTMENT SGT. TRACY BROWN IS PRESENT DURING THE CONVERSATION BETWEEN MR. CUNNINGHAM AND MR. FITZPATRICK. { COURTHOUSE VIDEO IN FILE }

ON MARCH 12, 2014, MR. FITZPATRICK GOES TO THE MCMINN COUNTY CIRCUIT COURT CLERKS OFFICE AND FILES FOR A PETITION FOR ORDER OF PROTECTION AND ORDER OF HEARING AGAINST JEFF CUNNINGHAM. MR. FITZPATRICK STATES IN HIS AFFIDAVIT THAT MR. JEFF CUNNINGHAM PHYSICALLY AND VERBALLY ASSAULTED HIM ON THE MORNING OF FEBRUARY 18, 2014, AND THAT THE ASSAULT TOOK PLACE ON THE SECOND FLOOR OF THE MCMINN COUNTY COURTHOUSE IN THE HALLWAY IN FRONT OF CONGRESSMAN CHUCK FLEISCHMANN'S LOCAL OFFICE. MR. FITZPATRICK FURTHER STATES ACTING UPON FIVE PRIOR INTERACTIVE CONTACTS AND EXPERIENCES, MR. CUNNINGHAM APPROACHED HIM UNINVITED AND UNSOLICITED ON FEBRUARY 18, 2014, TO COMMUNICATE HIS THREAT OF PHYSICAL HARM. IN FACT, MR. CUNNINGHAM'S UNINVITED AND UNSOLICITED APPROACH IS CUNNINGHAM'S WAY OF STALKING ME, AND SEEKING

AGENCY STATEMENT:

ME OUT TO COMMUNICATE HIS THREAT OF PHYSICAL HARM AND WAS FORSEEABLE AND FORESEEN. MR. CUNNINGHAM'S FEBRUARY 18, 2014, ASSAULT WAS WITNESSED AND AUDIO RECORDED. MR. CUNNINGHAM HAS BLOCKED ME SIX TIMES FROM APPEARING BEFORE THE MCMINN GRAND JURY TO REPORT UPON MASSIVE GOVERNMENT CORRUPTION THAT INCLUDES MR. CUNNINGHAM AS ONE OF THE PRINCIPAL CRIMINAL ACTORS. MR. FITZPATRICK STATES "I INTEND TO PRESENT MYSELF NEXT WEEK TO LEGAL JURORS OF THE MCMINN COUNTY GRAND JURY, MARCH 18, 2014, THE THIRD TUESDAY OF THIS MONTH. I INTEND TO REPORT MR CUNNINGHAM'S OUTLAWRY TO THE GRAND JURY SCREENING PANEL AT THAT TIME (A GROUP OF THREE LEGALLY RECOGNIZED JURORS THAT CANNOT INCLUDE MR. CUNNINGHAM.

MR. CUNNINGHAM SAYS HE WAS APPOINTED THE GRAND JURY FOREMAN OF MCMINN COUNTY BY JUDGE AMY REEDY AND WAS SWORN IN SOMETIME BETWEEN SEPTEMBER 2011 AND NOVEMBER 2011 ALTHOUGH HE IS NOT SURE OF THE DATE. MR. CUNNINGHAM ALSO STATES THAT HE HAS RESIGNED THAT POSITION AND CONCLUDED HIS SERVICE EFFECTIVE FEBRUARY 28, 2014. MR. CUNNINGHAM STATES THAT HE FIRST MET WALTER FITZPATRICK SOMETIME SHORTLY AFTER HE WAS APPOINTED THE GRAND JURY FOREMAN. MR. CUNNINGHAM THINKS SOMETIME AROUND JANUARY 2012, MR. FITZPATRICK CAME TO THE MONTHLY SESSION OF THE GRAND JURY AND WANTED TO MAKE A PRESENTMENT. MR. FITZPATRICK TOLD MR. CUNNINGHAM AT THIS TIME THAT HE WAS THERE TO INFORM HIM THAT HE ( MR. CUNNINGHAM ) AND THE MCMINN COUNTY GRAND JURY WAS ILLEGALLY IMPANELED AND WAS OPERATING ILLEGALLY. MR. CUNNINGHAM SAID HE TOLD MR. FITZPATRICK THAT HE HAD BEEN ASKED TO SERVE AND HAD BEEN SWORN IN BY A CRIMINAL COURT JUDGE AND THAT HE THOUGHT HE WAS SERVING LEGALLY. MR. CUNNINGHAM STATES THAT HE TOLD MR. FITZPATRICK THAT IF HE WANTED HIM REMOVED THAT HE SHOULD GO BEFORE THE CRIMINAL COURT THAT HAD IMPANELED HIM. MR. CUNNINGHAM SAID MR. FITZPATRICK WANTED TO PRESENT BEFORE THE GRAND JURY WITHOUT MY ( MR. CUNNINGHAM ) PRESENCE IN THE GRAND JURY ROOM. MR. CUNNINGHAM TOLD HIM THAT WOULD NOT HAPPEN. MR. CUNNINGHAM STATES THAT HE DOES NOT RECALL HOW MANY TIMES THAT MR. FITZPATRICK WANTED TO PRESENT TO THE GRAND JURY BUT HE THINKS IT WAS SEVEN OR EIGHT TIMES. MR. CUNNINGHAM SAYS THAT MR. FITZPATRICK ALWAYS HAD DOCUMENTS THAT HE WANTED THE GRAND JURY TO READ AND MR. CUNNINGHAM STATES THAT HE DID READ MANY OF THEM TO THE GRAND JURY AND COPIES WERE ALSO PROVIDED TO JURORS. MR. CUNNINGHAM SAYS THAT GRAND JURY MEMBERS SENT WORD TO MR. FITZPATRICK THROUGH HIM THAT THEY DID NOT WANT TO HEAR ANYMORE ALLEGATIONS FROM HIM, AND DURING THE DECEMBER 2013, GRAND JURY SESSION THAT EACH INDIVIDUAL MEMBER SIGNED OFF TO

THAT. MR. CUNNINGHAM SAYS THAT DURING THE JANUARY 2014, GRAND JURY SESSION THAT ONE MEMBER ASKED HIM IF THEY SHOULD BE AFRAID OF MR. FITZPATRICK AND WHEN THAT SESSION ADJOURNED THAT HE ( MR. CUNNINGHAM ) ASKED MCMINN COUNTY SHERIFF DEPUTIES TO CLEAR THE HALLWAY WHILE THE GRAND JURY MEMBERS EXITED THE COURTHOUSE.

MR. CUNNINGHAM INFORMED ME THAT MR. FITZPATRICK HAD BEEN SENDING OUT E-MAILS THAT HE WAS GOING TO HAVE SHERIFF JOE GUY AND MR. CUNNINGHAM ARRESTED. ON THE MORNING OF FEBRUARY 18, 2014, I WENT TO THE GRAND JURY SESSION AND SAW MR. FITZPATRICK SITTING OUTSIDE OF THE GRAND JURY ROOM. MR. CUNNINGHAM STATES THAT HE APPROACHED MR. FITZPATRICK AND ADVISED HIM THAT HE WOULD NOT ALLOW HIM TO PRESENT TO THE GRAND JURY, THAT MR. FITZPATRICK DOES NOT FOLLOW THE RULES, THAT MR. CUNNINGHAM THINKS MR. FITZPATRICK HAS GIVEN FALSE STATEMENTS TO THE GRAND JURY AND THE GRAND JURY DOES NOT WANT TO HEAR UNRELIABLE TESTIMONY MAKING THE SAME CLAIMS THAT THE GRAND JURY SAYS THAT THEY DO NOT WANT TO HEAR ANYMORE.

ON MARCH 14, 2014 THIS INVESTIGATOR INTERVIEWED MCMINN COUNTY SHERIFF SGT. TRACY BROWN. SGT. BROWN STATES THAT HE WAS PRESENT FEBRUARY 18, 2014 OUTSIDE OF THE MCMINN COUNTY GRAND JURY ROOM WHEN JEFF CUNNINGHAM AND WALTER FITZPATRICK HAVE A CONVERSATION. SGT. BROWN SAID HE HEARD MR. CUNNINGHAM INFORM MR. FITZPATRICK THAT HE WOULD NOT ALLOW HIM TO PRESENT BEFORE THE GRAND JURY AND MR. FITZPATRICK WAS QUOTING LAWS THAT SGT. BROWNS SAYS THAT HE DID NOT UNDERSTAND. SGT. BROWN SAID THAT HE NEVER DID SPEAK WITH MR. FITZPATRICK AND DID NOT ESCORT HIM FROM THE COURTHOUSE. SGT. BROWN SAID THE CONVERSATION BETWEEN MR. CUNNINGHAM AND MR. FITZPATRICK MAY HAVE LASTED FIVE MINUTES AND MR. CUNNINGHAM DID NOT ASSAULT MR. FITZPATRICK IN ANY FORM.

ON MARCH 14, 2014, THIS INVESTIGATOR INTERVIEWED GWEN CHRISMAN. MRS. CHRISMAN WORKS AS A DEPUTY CLERK FOR THE MCMINN COUNTY CIRCUIT COURT CLERK. MRS. CHRISMAN STATES ON MARCH 12, 2014, THAT SHE WAITED ON WALTER FITZPATRICK AT THE COUNTER WHEN MR.

FITZPATRICK FILED FOR THE PETITION FOR ORDER OF PROTECTION AND ORDER FOR HEARING AGAINST JEFF CUNNINGHAM. MRS. CHRISMAN STATED THAT MR. FITZPATRICK ALREADY HAD HIS PETITION COMPLETED AND SIGNED. SHE SAID THAT SHE ADVISED MR. FITZPATRICK THAT HE SHOULD NOT HAVE SIGNED IT WITHOUT BEING SWORN IN BY HER. AT THIS TIME SHE HAD HIM SWORN IN AND ASKED HIM TO TAKE THE OATH WHICH HE DID AND TO INITIAL ABOVE HIS

THE APPEAL WAS DISMISSED IN THE COURT OF CRIMINAL APPEALS DUE TO FAILURE TO COMPLY WITH RULE 29 (A) OF APPELLATE COURT.

AFTER BEING FOUND GUILTY AND SENTENCED IN THE CASE OF 12-108 (TAMPERING WITH GOVERNMENT RECORDS) IN MONROE COUNTY, THE DEFENDANT APPEALED HIS CASE ON 02/12/2013 THROUGH THE COURT OF CRIMINAL APPEALS IN KNOXVILLE, TN. WHILE THE APPEAL WAS STILL PENDING, THE DEFENDANT WAS INDICTED BY THE MCMINN COUNTY GRAND JURY IN MARCH 2014 FOR CRIMES OCCURRING EARLIER IN 2014. WHILE THE DEFENDANT'S NEW INDICTMENT WAS PENDING, THE CRIMINAL COURT OF APPEALS DENIED THE DEFENDANT'S CLAIMS ON 04/11/2014, AND CONCLUDED THAT THE TRIAL COURT DID NOT ERR. ON 06/24/2014, THE DEFENDANT APPEALED CASE 12-108 TO THE SUPREME COURT. THE SUPREME COURT HAS NOT RENDERED A DECISION ON THE APPEAL.
