## ORDER IMPOSING CIVIL RESTITUTION LIEN

Sections 960.292 and 960.293, Florida Statutes, require this court to impose a Civil Restitution Lien upon the property of the above named Defendant. Accordingly, upon conviction of the Defendant, this court finds and rules as follows:

- 1. The above-named Defendant shall be liable to Dixie County, Florida, whose address is P.O. Box 1206, Cross City, Florida 32628, for the following damages and losses incurred by the County for the Defendant's incarceration costs and other correctional costs: \$50.00 per day for 30 days, which is the number of days of the Defendant's sentence. The Defendant's conviction is for an offense other than a capital or life felony.
- 2. The imposition of this order creates a present and future lien on any property owned by the Defendant, excluding homestead, until this debt is paid in full to Dixie County, Florida, but for no longer than twenty (20) years from the date hereof. The interest rate of such lien shall bear the rate of interest set forth in Section 55.03, Florida Statutes.
- 3. Nothing contained in this order shall preclude Dixie County, Florida, from using or collecting other forms of restitution available to it as provided by law.
- 4. This court hereby retains jurisdiction of the parties hereto and the subject matter hereof for the purpose of enforcing this Order and for entering such other and further Orders as may be just and proper in and about this cause.
