16 The Defendant previously appeared before the Court with counsel and entered a plea
17 of guilty to the crime(s) of CHILD ABUSE, NEGLECT, OR ENDANGERMENT (Category
18 B Felony), in violation of NRS 200.508(1); thereafter, on the 20th day of June, 2016, the
19 Defendant was present in court for sentencing with her counsel, CHRIS RASMUSSEN, ESQ.,
20 and good cause appearing,

21 THE DEFENDANT IS HEREBY ADJUDGED guilty of said offense(s) and, in
22 addition to the \$25.00 Administrative Assessment Fee, a \$150.00 DNA Analysis fee including
23 testing to determine genetic markers, and \$3.00 DNA Collection fee, the Defendant is
24 sentenced as follows: to a MINIMUM of TWENTY-FOUR (24) MONTHS and a
25 MAXIMUM of SIXTY (60) MONTHS in the Nevada Department of Corrections (NDC);
26 SUSPENDED; placed on PROBATION for an indeterminate period not to exceed FIVE (5)



- 5 Confession of Judgment (CCOJ).
- 6 3. Undergo a mental health evaluation; complete any recommended counseling.
- 7 4. Maintain full-time employment, or attend school full-time; for any month not in school or
- 8 working, complete 16 hours of community service.
- 9 5. Abide by a curfew if imposed by Parole & Probation (P&P).
- 10 6. Refrain from the use, control, or possession of alcohol.
- 11 7. Report to P&P within 48 hours.
