Re: Matter of the usurpation of the
Presidency by Barack Obama

Dear President Trump,

I write to you today concerning a matter of grave national security that arises from the fact that Barack Obama usurped the Presidency of the United States in 2008 and again in 2012. The fact that this took place during time of war makes it even more serious.

I initially started blowing the whistle about Obama in 2008. I have written several articles, letters to the Editor, letters to various government officials and have blogged about this issue on the Post and Email, the BBC, New York Times, Buffalo News, Twitter, Facebook, Topix and other websites.

I was also interviewed on this issue by ABC, NBC and CBS affiliates in Buffalo, New York and have sued Obama in SCOTUS.

In the recent past, Sheriff Joe Arpaio's Maricopa County, Arizona Cold Case Posse has determined that Barack Obama's proffered Birth Certificate *is a forgery*. His Selective Service card is also a *forgery*. This issue **must** be addressed by Attorney General Jeff Sessions and the Joint Chiefs of Staff.

The fact that Obama entered the Office of the President of the United States, by fraudulent means and without legal bona-fides during time of war, makes Barack Obama a spy under the Uniform Code of

Military Justice. It also makes Obama a traitor to the United States under 18USC, Part 1, Chapter 115, Sec.2381.

In 2012 I filed a formalized Citizen's Arrest against Barack Obama properly making service on then Attorney General Eric Holder. I have also filed Police report(s) with the Tonawanda, NY Police as well as the D.C. Police Department, the Federal Bureau of Investigation, the DoD and the Justice Department. I have been interviewed on my charges by the Secret Service, the FBI and DOJ Agents.

The Police report filed with the Tonawanda, NY Police was forwarded by their Chief to the Secret Service and to the D.C. Police. It is illegal to impersonate a public official under the D.C. Code as well.

Barack Obama is not an Article II, Sec. 1 (USConst) "Natural Born Citizen". As a matter of fact, neither is John McCain, Rafael "Ted" Cruz, Piyash "Bobby" Jindal, Marco Rubio or Arnold Swarzenegger.

The U.S. Supreme Court in *Minor v. Happersett, 88 US 162 (1874)* **unanimously ruled** that a "Natural Born Citizen" is one born in the United States to Parents who are both U.S. Citizens themselves. SCOTUS has reaffirmed this definition in several other cases.

You, yourself, meet this requirement as did **all other Presidents** except the first (7) Presidents who were grandfathered in, Barack Obama and Chester Arthur.

It was discovered only after Arthur died that he was not a "Natural Born Citizen". Obama, on the other hand, has been exposed while he can still be arrested and tried for usurping the Presidency during war time, which involves espionage, fraud, treason and other crimes.
