The Appellant hereby **MOVES FOR EXPEDITIOUS COSIDERATION**

and adjudication of this case under provision of Circuit Rule 27 (f) on the ground that, to avoid irreparable harm, relief is needed in less time then would ordinarily be required for this court to receive and consider a response.

The nature of this case regards a national security issue, should the *ultra veres* ascendancy into the Vice-Presidency of the United States and/or the Presidency of the United States by the Defendant U.S. Senator Kamala Devi Harris be allowed to occur.
